

ANNEXURE 1:

Compulsory Annual Monitoring Report:

Providers are required to submit an annual monitoring report to Umalusi. These must be submitted to Umalusi annually by the **28 February** of every year. **No** extensions will be allowed. The monitoring instrument is forwarded to providers on an annual basis – and your institution should receive it shortly. If a provider is found to be non compliant after monitoring, the provider will not receive an extension of provisional accreditation. Such an outcome will be reported to the Department of Education and may have implications for the registration status of your institution.

Compulsory Annual Provider Workshop:

Umalusi conducts compulsory annual provider workshops in September of every year. Providers are advised to attend such workshops if they wish to retain their provisional accreditation status. The workshops address important developments in the Umalusi accreditation system and provide feedback on annual self-evaluations, all of which will impact on your provision. Providers will be informed of the annual workshop in good time.

Provider Conference
